A BILL

To establish a student committee to evaluate the condition and standings of all buildings on campus, and provide recommendations for said buildings.

1	Be it enacted by the Senate of the Student Government
2	Association of Westminster Choir College of Rider University
3	assembled,
4	SECTION 1: SHORT TITLE
5	SHORT TITLE.—This Act may be cited as the
6	"Facilities Review Committee Act".
7	SECTION 2: FINDINGS AND PURPOSE
8	(1) FINDINGS.—The Senate finds the following:

Bill Enacted 10/20/2009 by the Senate of the Westminster Choir College SGA

1	(A) The Westminster Choir College campus will
2	need facilities improvements over the next few years.
3	(B) There currently is no study that takes into
4	consideration the student's views on facilities development.
5	(C) Students living and/or studying on the
6	Westminster Choir College campus have a unique insight
7	into the campus's facility needs.
8	(2) PURPOSE.—The purpose of this Act is to:
9	(A) Establish an ad-hoc committee of the Student
10	Senate of no more than five members that would evaluate
11	the condition, quality, and purpose of each building.
12	(B) Enable said committee to provide
13	recommendations of changes that need and/or should be
14	made.
15	(C) Create an active and ongoing dialogue
16	between students and administration by any means
17	necessary.
18	(D) Give students a strong voice in changes that
19	should be need and/or should be made to this campus and
20	its buildings.
21	(E) Assign the committee the official name the,
22	"Facilities Review Committee".
23	SECTION 3: (CREATION OF THE FACILITIES REVIEW
24	COMMITTEE)
25	(1) IN GENERAL.— Upon passage of this bill, the
26	"Facilities Review Committee" will be established
27	and will be responsible for following, at least, all of
28	the guidelines set forth in Section 2, number 2. Mr.

1	Lakeland would serve as chair of the committee, and
2	membership shall be as follows:
3	a. Immediately following the passage of this bill,
4	Mr. Lakeland shall nominate four other persons
5	to serve on this committee. Immediately after
6	nomination and any discussion, the senate shall
7	vote on the confirmation of the nominees.
8	SECTION 4: ENACTMENT
9	This Act shall be enacted immediately upon its
10	passage in the Senate of the Student Government
11	Association of Westminster Choir College of Rider
12	University assembled.
