## VII. New Business

- i. Presentation on Tuition by Dean Campbell
  - 1. Basic Principals are to keep tuition low and increase what they do with financial aide.
  - 2. 4.9% increase in tuition. Typical increase has been from 5.5-6.5%. Originally they thought it would fall where it did last year at around 5.8%. The Economy crash made them rethink this, which is where 4.7% came from. This is the lowest increase since 2001. Increase is critical because they need to address the needs being presented this year.

They are looking for more ways to make financial aide go further. They did not budget for the \$650,000.00 extra they spent in financial aide. So, they want to make sure they are budgeted for that.

Circumstances with the economy and family situations have changed, so if you are thinking of leaving you should come first to financial aide and try to work things out.

For example, they are offering grants to rising juniors in the fall to those who live on campus. The goal is to keep loan and debt rates down.

Number one investment is to financial aide so they can better serve the students.

This summer they are looking to do more improvements over the summer, specifically to the practice rooms. Parking lot is still being worked on however cannot be guaranteed for the fall 2009 semester. Another project is signage, not only in front of Williamson in other non-specified areas as well.

Vice President Godfrey stated last Senate meeting is April 30<sup>th</sup>.

Senator Magargal asked about graduate student limited financial aid, how might it be increased?

It was just increased, however until they secure more endowed awards it cannot be any more that it is.

At the graduate level you have 9 credits versus 12 credits at the undergraduate level. Some find it better to do part-time graduate school, because it is more affordable.

However, scholarships are usually given to full-time students, but not limited to full-time students. Your needs need to be communicated to the financial aide department.

Senator Friars asked what the overload charge is?

It is half of the credit charge, half of \$890.00.

Senator Sweeney asked if there is any way to reinstate or redistribute scholarship money if the student switches from full-time, to part-time, and back to full-time?

It needs to be addressed to the financial department personally. It is dependent on the situation. As long as they know what the situation is, they will work with you during the time of economic hardship.

ii. Smoking Reform Act Bill

1. The origins lie in a constituent wanting to make the campus a smoke free environment. However, there needed to be a compromise. They are saying to smokers "you can still smoke" and you will not have to go very far. But to everyone else we are saying, "second hand smoke is a terrible problem to be addressed." Also, the gazebo allows smokers to smoke in an area not near the dorms for shelter near the rain.
2. Senator Friars says that this was brought up at the G.A. meeting last Sunday, resulting in a unanimous vote for a designated smoking area. What was in question was if we should get one or two gazebos one for smokers and another for non-smokers. Essentially what is left up to the senate is whether there should be another gazebo for non-smokers.
