 - Departmental approval based on satisfactory evidence of musicianship, singing and piano skills, professional teaching dispositions (e.g., punctuality, communication, accountability, ethical behavior) and potential for success in teaching as evidenced in coursework, grades and successful completion of a portfolio review.

- 4. It is my responsibility to contact the cooperating teacher and arrange an interview within 10 days once Debbie Williamson notifies me that a potential placement site has been identified for me.
- 5. I understand that all paperwork requirements (résumé, background checks, fingerprinting, medical tests) must be submitted to the district by November 1 for spring placements and April 1 for fall placements. I understand that it can take weeks to get an appointment for finger printing and for paperwork to be processed. I understand that if I delay in submitting the forms, my placement may not be approved by the school district in time and will therefore be delayed a semester.
- 6. I understand that although I may request a specific semester, school, type of music teaching or level, my requests may not be honored. I recognize that the placement decision of the

Coordinator of Student Teaching shall be final.

- 7. I understand that the Department does not recommend a placement a cooperating teacher who is one of my former teachers.
- 8. I understand that there are expenses and application deadlines associated with student teaching and graduating, including:
 - A student teaching fee that will be billed to my account
 - Praxis tests that I must register for at the beginning of student teaching
 - Transportation costs for getting to my placement site (e.g., fuel, tolls)
 - New Jersey licensure fees
 - Graduation application deadline
- 9. I understand that if I do not do the following, my graduation and certification paperwork will not be processed.
 - complete all program requirements
 - have official transcripts from courses completed outside of Rider
 - submit all required applications and pay all fees associated with student teaching and certification
 - have passing scores for all New Jersey certification tests on file
- 10. I understand that I am expected to have a car in order to get to my placement site. I also understand that I do not have a car, I must provide Dr. Holcomb, the Coordinator of Student Teaching with an acceptable solution (e.g., a site near a bus route) before my application will be processes. I understand that choosing convenience over best fit could result in a diminished experience.
- 11. I understand that successful student teaching experiences and timely completion of senior portfolio, seminar, and course assignments are my priorities during the semester of student teaching. I understand that while enrolled in student teaching, I
 - cannot enroll in any applied lessons or classes other than the co-requisite classes, ME 587 and ME 595.
 - cannot participate in any college ensembles, private lessons, recitals or student-led performances.
 - cannot serve as an officer of a student organization.
 - should limit my off-campus activities and working hours.
 - am required to attend weekly seminars and ME 587 on Wednesday afternoons during my student teaching experience.
- 12. I understand that I am required to submit New Jersey Teacher Certification forms and fees no later than **November 15th** (if teaching during the fall semester) or **April 15th** (if teaching during the spring semester) regardless of what state I plan to eventually teach.
- 13. I understand I must register for ME 492, ME 587, and ME 595 by the last of classes in the fall or spring semester prior to the semester of student teaching or my placement may be cancelled.
