5	exercises continue to be not only a transitory recognition of
6	accomplishment, but also a legacy awarded both in presence and
7	by diploma;
8	Whereas the first honorary doctorate was awarded to Leopold Stokowski
9	in 1963 by the Board of Trustees of Westminster Choir College.
10	Since then, Westminster Choir College has awarded honorary
11	degrees to such notable leaders as Leonard Bernstein, William
12	Steinberg, Bob Hope, Wilhelm Ehmann, Sir David Willcocks,
13	John Rutter, Zubin Mehta, Riccardo Muti, Robert Shaw, Kurt

3	Whereas when an honorary degree is conferred upon an individual, they
4	are presented with an academic hood. In 2006 the colors on this
5	hood were changed from purple and gold, the colors of
6	Westminster Choir College, to cranberry and white, the colors of
7	Rider University.
8	Whereas the following statements represent the current
9	opinions/requests of the student body of Westminster Choir
10	College: Now, therefore, be it
11	Resolved, that the colors on all academic regalia shall now and always
12	remain purple and gold in accordance with Dean Annis'
13	confirmation that these are the official colors of Westminster
14	Choir College. In the case of honorary degrees, all future
15	academic hoods are to be returned to the colors of Westminster
16	Choir College in recognition of the rich history of this tradition.
17	Resolved further, that the Bachelor of Music degree academic hoods shall
18	continue to be pink while Bachelor of Arts in Music academic
19	hoods shall be returned to white.
20	Resolved further, that the name and seal of Westminster Choir College shall
21	now and always appear prominently on all diplomas that Rider
22	University confers on students from the Princeton Campus.
23	Resolved further, that the commencement exercises of Westminster Choir
24	College shall now and always take place in the Princeton
25	University Chapel.
26	Resolved further, that the Senate requests formal confirmation of the above
27	paragraphs from the Office of the Dean of Westminster Choir
28	College and/or the Office of the President of Rider University.
29	Resolved further, that the Senate requests the Executive Board of the

Student Government to proactively uphold this resolution in regular meetings with the administration. The Executive Board shall consult with the administration on matters of formatting and brand imaging of the Westminster Choir College name in the larger context of the commencement exercises. This Executive Board shall not comment on matters related to the commencement program or any musical selections.
